KNOW ALL MEN BY THESE PRESENT THAT WHEREAS The Owner

Proposes during the financial year now current and ending on the 31st day of December next to import or take out of bond without payment of import duties all or any machinery, tools, fixtures or supplies which may from time to time be required for the purposes of the processes carried on at his said registered factory.

AND WHEREAS it is required and has been agreed that:-

- 1) Upon each and every importation or taking out of bond of any machinery, tools, fixtures or supplies so required as aforesaid the Owner or his duly authorized Attorney or Agent shall make a complete list of each and every article or thing of the nature aforesaid imported or to be take out as aforesaid with respective value thereof attached to each such article or thing and shall sign such list in the presence of the Comptroller of Customs or some Proper Officer of the Customs Department who shall thereupon countersign the same in his official capacity, and
- 2) That the Owner or his Attorney or Agent as aforesaid shall declare to the truth of the contents of such list before the Comptroller of Customs or some Proper Officer of the Customs Department and
- 3) That each and every such list when so signed, countersigned and declared as aforesaid shall be attached as an exhibit to this bond.

NOW THEREFORE WE the Registered Owner of an Agricultural Factory whose registered number is _____ particulars whereof and the purposes for which the same is registered are duly entered in the Register of Agricultural Factories kept under the above-mentioned Act (hereinafter called the Owner) and
