TARIFF (AMENDMENT) ACT, 2019

AN ACT TO AMEND THE TARIFF ACT

[Date of Assent - 28th June, 2019]

Enacted by the Parliament of The Bahamas

1. Short title and commencement.

- (1) This Act, which amends the Tariff Act, 2018 (*No. 21 of 2018*) may be cited as the Tariff (Amendment) Act, 2019.
- (2) This Act shall come into force on the 1st day of July, 2019.

2. Amendment to section 2 of the principal Act.

Section 2 of the principal Act is amended by the insertion in the appropriate alphabetical order of the following new definition —

“ “**new vehicle**” means a motor vehicle having a mileage of two hundred miles or less or the equivalent;”.
