



TARIFF (AMENDMENT) BILL, 2021

A BILL FOR AN ACT TO AMEND THE TARIFF ACT

Enacted by the Parliament of The Bahamas

1. Short title and commencement.

- (1) This Act may be cited as the Tariff (Amendment) Act, 2021.
- (2) This Act shall come into force on the 1st day of July, 2021.

2. Amendment to the First Schedule to No. 21 of 2018.

Part C of the First Schedule to the Tariff Act is amended —
